## Dog Waiver

I hereby agree to the following regulations and conditions while staying at The Sheraton Atlantic City with my dog:

- I agree there is a \$50 non-refundable cleaning fee, per stay due at check-in.
- I agree to keep my dog with me or a designated individual at all times, and not leave my dog unattended in the room. Should dog be left in room unattended: Hotel reserves the right to remove my dog from my room. A \$200.00 disturbance fee will be added to my bill and I will be required to make arrangements to house dog elsewhere or depart. I also agree to release Sheraton Atlantic City from all liabilities for removing my dog from my room or any injuries to the dog.
- I agree to keep my dog out of all food & beverage facilities within the hotel including, which includes Tun Tavern, Boulevard's Cafe, Shoe Bar Lounge and the Club Lounge. I also agree to keep my dog out of the pool and Jacuzzi, or fitness center.
- I agree to be present while any member of the hotel staff, such as housekeeping or engineering, is in the room. Room cleaning must be scheduled in advance for a time when the dog is not in the room or the owner is present.
- I agree to keep my dog on a leash while in public areas or walking the dog. I will be responsible for damages or injuries caused by my dog. If I fail to keep my dog on a leash, Hotel reserves the right to ask me to leave without refund.
- I agree to prevent noise or any other disturbance by my dog, in the interest of other hotel guests. I will be responsible for compensation paid to other guests as a result of noise caused by my dog. I understand that the hotel reserves the right to ask me to leave without refund.
- I agree to keep only one dog in my room, which weighs less than 80 pounds.
